

For the first year the payment must be in lump sum. For the second year it is possible to pay half-yearly.

- **O** Rules of repayment: accept repayment according to the following academy rules
 - 1. When Certificate of Status of Residence has not been issued

 \rightarrow Application fee shall be demanded from the applicant.

2. When Certificate of Status of Residence has been issued but the applicant has not

applied for a visa and has not come to Japan

- →All fees except application fee shall be repaid, on condition that Admission Certificate and Certificate of Status of Residence is returned to the school.
- 3. When the application for a visa has been rejected at Japanese diplomatic establishments abroad and the applicant is unable to come to Japan

 \rightarrow All fees except application fee shall be repaid, on condition that Admission Certificate is returned to the school along with the confirmation of the visa rejection by the authorities concerned.

- 4. When the visa has been issued but the applicant has declined to enroll before arriving in Japan
 - →All fees except application fee and admission fee shall be repaid, only when the fact that his/her unused visa has expired is confirmed and Admission Certificate is returned.
- 5. When the student who entered Japan after obtaining a visa and enrolled in the school has dropped out

 \rightarrow All fees (application fee, admission fee, tuition, facilities fee, etc.) shall not be repaid.

6. When the applicant has entered Japan but not enrolled in the school

 \rightarrow It is regarded as equivalent to dropping out and the rule no.5 will be applied.

IV.The process of application to Entry

(1) Application

(1) Qualification for admission:

1. Persons who have been educated at regular schools for 12 years or more in countries outside Japan, or who within five years after graduation education.

2. The person who can submit the certificate of more than 150 hours of Japanese Language study in their own country. The person who has passed minimum level of Japanese Language Proficiency Test

- ① Persons who have acquired Japanese Proficiency Test Forth Grade
- ② NAT-TEST: more than N5
- ③ J-TEST: more than F grade or more than 250 point/500

- ④ TOP-J: more than A
- (5) Standard Test Business Japanese: 350 point
- ⑥ GNK Life & Business Style Japanese Language Test (B course): more than intermediate or pre-intermediate level
- ⑦ College/University Entrance Examination 450 points/750

(2) How to apply :

Fill up the necessary details in application form of our school and bring or send it to the office of local authorized agent of our school.
